- **Assistant Professor, Department of Archaeology and History of Art, Koç University, and Director of the Mustafa V. Koç Maritime Archaeology Research Center, 2017-Present**

As faculty within the College, my duties include designing and teaching undergraduate and postgraduate courses focusing on Maritime Archaeology, as well as administrative and committee duties. As Director of KUDAR (Koç University Mustafa V. Koç Maritime Archaeology Research Center), my responsibilities include the long-term planning and guidance of the center, establishing and maintaining international collaborations, overseeing the staff, and liaising with the center’s Executive and Advisory Boards.

- **Senior Fellow in Residence, Research Center for Anatolian Civilizations (ANAMED), Koç University, 2016-2017.**

I pursued a component of the AMD (Ancient Maritime Dynamics) program called ‘Cities, Sites, and Seas’, with two elements. One tests the accuracy of MISAMS’ present GIS models by incorporating new data on six wreck sites along the Anatolian coastline and comparing the new models against the old. The second element compares the spatial and chronological characteristics of Aegean maritime activity against the locations and histories of Constantinople, Phocaea, Smyrna, Ephesus, Miletus, Myndos, and Halicarnassus. This second component assesses the role these cities may have in the construction of Aegean maritime space: Are they on gradients between concentrations of activity, are they loci of activity, and does this relationship change with fluctuations in the port itself?

- **Marie Curie Fellow and PI, MISAMS Project, University of Birmingham, 2013-2015.**

MISAMS (Modeling Inhabited Spaces of the Ancient Mediterranean Sea) was a cross-disciplinary study combining new theories in Archaeology, Anthropology and Social Geography with field surveys off the southern coast of Turkey to model the construction and inhabitation of maritime space in the ancient Mediterranean Sea. This project re-studied the discipline’s data with new perceptions that stress two characteristics: cross-cultural patterning instead of idiographic labels, and that the sea is a constructed, inhabited landscape equivalent to that on land, thus embodying a maritime community. MISAMS’ goal was to re-fashion maritime archaeology into an anthropological study focusing on people’s habits, not objects.

- **Director, Kyrenia Shipwreck Collection Restoration Program, 2010 – 2013.**

Depicted on stamps and passports, the 4<sup>th</sup>-century BC shipwreck excavated off Kyrenia, Cyprus, represents both the formative era of nautical archaeology and the island of Cyprus to the world. Following the partition of the island in 1974, however, the curation and maintenance of this collection has been inadequate. Coordinating an international effort with the UNDP, ICOMOS-ICUCH, UNESCO, the European Commission, and the United States and Australian Embassies, our efforts generated the necessary political, communal and financial support to update and revitalize the current infrastructure in Kyrenia to stabilize, manage, and display this collection to current standards.

- **Director, Nautical Archaeology Society Maritime Heritage Awareness training, 2007-2010.**

Working with the Nautical Archaeology Society of Great Britain, I developed and implemented a bi-communal, public-outreach training course licensed by the NAS that teaches dive businesses and individuals in Cyprus the proper ways to care for maritime heritage material underwater, and the reasons why such activities are important. The content of this course meets the regulations in UNESCO’s 1999 Second Protocol and 2001 Convention for the Protection of Underwater Cultural Heritage. Nine businesses and six individuals in the Turkish- and Greek-Cypriot communities earned this certification.

As a component of the Ancient Maritime Dynamics (AMD) project, this investigation is modeling and understanding the long-term changes in this maritime landscape encompassing fundamental social, religious, and economic changes. This work includes the inventorying and cataloguing maritime heritage on land and underwater to reconstruct shifting patterns of activity, generating viewshed models of the coastline to recreate the changing relationship with the sea, geomorphological studies, and working with the local community to collect information and to protect the maritime heritage still in situ. With permission from the Soprintendenza della Campania and the Consorzio di Gestione Area Marina Protetta Punta Campanella, an Institutional Agreement with the University of Salerno, and patronage from the Citta di Amalfi.

As part of the regional surveys under the direction of Çiler Çilingiroğlu at Ege University, our survey efforts are identifying and documenting archaeological heritage on the coastline and underwater for further research and management efforts.

Underway since 2009 under the aegis of the Institut National des Sciences d'Archéologie et du Patrimoine, Université Mohamed V-Agdal, the University of Southampton, and directed by Athena Trakadas, the 2015 season conducted magnetic resonance surveys beyond the conventional boundaries of the Roman-era coastal site of Lixus to assess the extent of the site into the contiguous alluvial plains. Our results, finding evidence of contemporaneous inhabitation, are informing local policy measures and the management and protection of the surrounding area.

As part of the regional survey under the direction of Gunder Varinlioğlu at Mimar Sinan University in Istanbul, our coastal and underwater survey efforts pursued two goals. First, the results of this micro-regional analysis informed and tested the present maritime regional model at the heart of the MISAMS project at the University of Birmingham and, second, combined with Varinlioğlu's terrestrial work, roughly modeled the maritime landscape of this portion of ancient Rough Cilicia.
